Effective January 1, 2021


Dear Resident,

Effective immediately, all residents must call Johns Disposal at 262-473-4700 to schedule each bulk items collection. Your items will be collected today as a courtesy, but we will only collect bulk items which have been scheduled in advance moving forward. You will still receive up to one collection per month at no additional charge. Bulk items collection includes items that do not fit in your garbage or recycling cart, such as: furniture, extra bags of garbage, tires (up to two per month, maximum eight per year), etc.
